# Letter from the President



Dear Members of the GDN section,

I would like to welcome you to the sixth issue of our GDN newsletter. 2022 has also proved to be a year with uncertainty related to the pandemic and health requirements regarding international travel and participation in public events. However, things have been beginning to change and many on-site events have been already organized. The situation was expected to be better this year than it was last year. We were therefore optimistic about the 22nd International Conference on Group Decision and Negotiation, which we had planned to hold in a hybrid format (in person & virtually), in Moscow, Russia.

However, our plans were once again frustrated and we were not able to meet in person with most of the members of our community. This time for a different reason: the diplomatic impact of the attack of the Russian state on Ukraine. Our community remains in solidarity with the people of Ukraine, victims of this situation and we hope for a peaceful resolution of this conflict. Moreover, we express our solidarity with Russian academics and researchers who are as dismayed by this situation as we are. In line with these principles, the GDN Section Board took the decision to hold our annual Conference virtually (online), for the second time.

Therefore, in June of this year, the GDN 2022 Conference was held in virtual format. In spite of the format, it was an outstanding conference with interesting presentations, rich discussions, and inspiring keynote speakers, that far exceeded the expectations of our community. I would like to thank the Honorary Chair of GDN 2022, Rudolf Vetschera, the General co-Chairs, Fuad Aleskerov and Liping Fang, and the Program Chairs, Danielle Costa Morais and Alexander Lepskiy, for all their hard work in ensuring that the conference became so memorable and inspiring.

As expected, among the most exciting moments of the conference were the announcements of the Awards. This started with the GDN Section Award, the highest recognition for achievement that a member of our international community can receive. The award was announced at the opening session and was followed by a superb keynote address by the Awardee of this year, Mareike Schoop. Congratulations Mareike; well deserved! Then, we had the announcement of the Gregory Kersten GDN Journal Best Paper Award, given during the GDN Section business meeting for the best paper published in the GDN Journal in 2021. Also, during the business meeting, the GDN Springer Best Paper and the GDN Springer Best Student Paper were announced, as were, in both cases, Runner-up papers. These awards were based on the quality of the full paper and on the presentation and discussions during a Special Award Session at the Conference. I would like to express my appreciation to the members of both Committees for these awards, for their thorough work. See the newsletter for further details and I hope this will prompt you to make submissions at the conference next year.

Since 2019, a GDN Cluster at the INFORMS Annual Meeting has been formed, with a few invited sessions. In October 2022, the INFORMS Annual Meeting will be held in person, in Indianapolis Indiana. The GDN cluster will host two sessions: MCGDM: Multicriteria Group Decision Making Models and Negotiation Models and Analysis. For future years, we strongly encourage the members of the GDN community to submit their work and to organize sessions in the GDN cluster at the INFORMS Annual Meeting.

In 2023, the GDN conference will be held in Tokyo, Japan, from June 11 to 15. We cordially invite you to submit your contributions. We sincerely hope that we shall be able to meet in-person again in 2023. The conferences in 2021 and 2022 were virtual events which means that Tokyo will be the first time in three years that we can enjoy the extra advantages of being together in the same place. # 1. SOCIETY NEWS

## 1.1. Report on the 22th International Conference on Group Decision and Negotiation (GDN 2022)

The 22nd International Conference on Group Decision and Negotiation (GDN 2022) was held virtually from June 12 to 16, 2022. GDN 2022 was the second virtual international conference on group decision and negotiation.



GDN 2022 was sponsored by the Group Decision and Negotiation (GDN) Section, Institute for Operations Research and the Management Sciences (INFORMS), and was a truly international conference, with submissions from authors located in 24 countries situated in Asia, Australia, Europe, North America, and South America. A total of 62 papers were presented. 90 people attended the conference.

The GDN 2022 conference program was composed of:

- Four Keynote Sessions,
- A Plenary Panel entitled “GDN: Past, Present and Future,”
- 15 Parallel Technical Sessions,
- Doctoral Consortium on June 12,
- GDN Springer Best Paper Competition Session,
- GDN Springer Best Student Paper Competition Session,
- One Group Support System Demonstration Session, and
- A Panel.

The finalists of the GDN Springer Best Paper and Best Student Paper Competitions presented their papers twice: once in the respective competition session and once in the normally scheduled session. A virtual Welcome Reception was also organized to enable person-to-person and small-group interactions. Presentation scheduling was able to take into account the various time zones of the presenters. During the conference, the GDN Section Business Meeting and the Group Decision and Negotiation Journal Editorial Board Meeting were also held virtually.

The GDN 2022 conference proceedings are organized and published in two volumes. After a rigorous blind review process, 9 full papers were chosen for inclusion in a volume published by Springer (<https://link.springer.com/book/10.1007/978-3-031-07996-2>). The second volume is composed of 53 full and short papers as well as

abstracts, also selected in a thorough blind review process. Information about the second volume is available on the conference website (<http://gdnconference.org/gdn2022/local-proceedings/>).

### 1.2.1. 2022 Group Decision and Negotiation Section Award

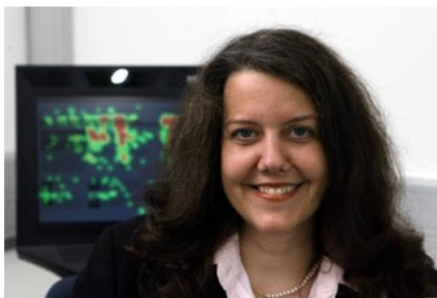

##### Mareike Schoop



Mareike Schoop is a leading researcher in the field of electronic negotiations. Her main contribution is in the adaptation of speech act theory to the domain of negotiations. She has developed the Negotiation Support System (NSS) NEGOSST, which was the first NSS to integrate document support in the form of semantic enrichment with communication support based on speech act theory and analytical negotiation support. NEGOSST is an important platform for conducting empirical research in electronic negotiations. Professor Schoop has brought many promising young researchers to the field of e-negotiations. She has served the GDN community in many ways. She organized the GDN conference in 2017 in Hohenheim and served as chair of the doctoral consortium for several other GDN conferences. She was the treasurer of the INFORMS GDN Section, and since 2020, has been the co-Editor-in-Chief of the GDN Journal.

### 1.2.2. Gregory Kersten GDN Journal Best Paper Award

To commemorate the late Gregory Kersten, the INFORMS Section on Group Decision and Negotiation establishes the annual “Gregory Kersten GDN Journal Best Paper Award” for outstanding papers published in the GDN journal. The Award has been sponsored by The Gregory Kersten Foundation.



The Gregory Kersten GDN Journal Best Paper Award is given annually to a paper published in the journal Group Decision and Negotiation in the previous calendar year that best contributes to the advancement of the theory and/or practice of group decision and negotiation. A paper is eligible for the award if it has appeared in one of the issues published during the calendar year, or if it is available as “Online First Article” on December 31st of that year. No paper can be selected for the award more than once.

Papers are nominated for the award by the Departmental Editors of the GDN journal. Associate Editors of the journal can nominate papers via the respective Departmental Editors. Each Departmental Editor can nominate up to three papers for a given year. In addition, members of the Award Committee, who are not Departmental Editors of the journal, can nominate up to three papers for a calendar year.

The Award Committee consists of five members, according to the Bylaws, including the President of the Informs GDN Section, the Editor in Chief of the GDN journal, the most recent winner of the GDN section award, other winner of the GDN section award and the most recent winner of the Gregory Kersten GDN Journal Best Paper Award, appointed by the GDN section council. ***The Award committee of 2022 was: Adiel de Almeida; Mareike Schoop/Gert-Jan de Vreede; Raimo Härmäläinen; Liping Fang; Ingmar Geiger.***

### 1.2.3. 2022 GDN Best Conference Papers

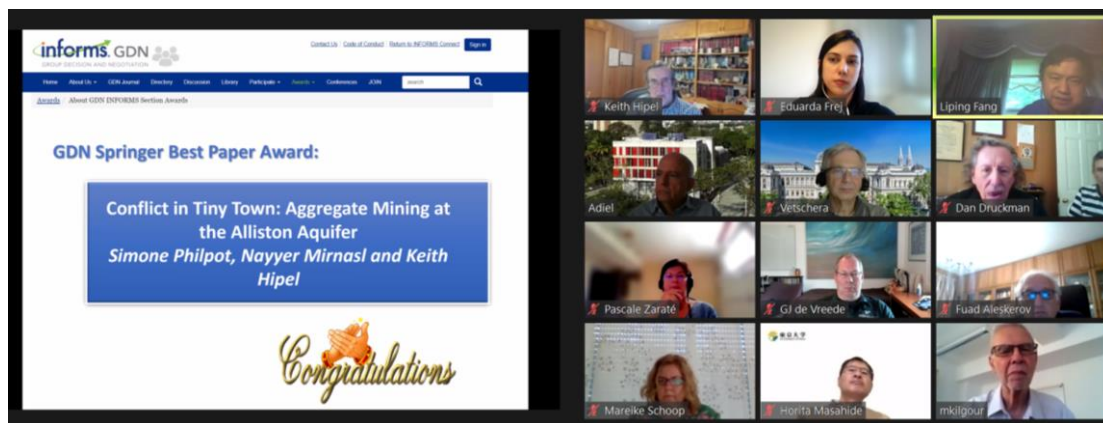

### Call for papers

You are cordially invited to submit papers to the 23rd International Conference on Group Decision and Negotiation, GDN 2023, 11-15 June 2023, Tokyo, Japan.

The field of Group Decision and Negotiation focuses on decision processes with at least two participants and a common goal. Such processes are complex and self-organising and constitute multi-participant, multi-criteria, ill-structured, dynamic, creative, and often evolutionary problems. Major approaches include:

1. Information systems, in particular negotiation support systems (NSSs) and group decision support systems (GDSs)
  2. Cognitive and behavioural sciences as applied to group decision and negotiation
  3. Conflict analysis and resolution
  4. Applied game theory, experiment and social choice
  5. Artificial intelligence
  6. Management science as it relates to group decision making and negotiation.
- Many research initiatives combine two or more of these approaches.

Group Decision and Negotiation can be performed in an intra-organisational as well as an inter-organisational context. Both consist of complex processes, including preference elicitation, proposals and counter-proposals, preference adjustment, and choice. Communication and decision making are the two key process steps in Group Decision and Negotiation and thus require sophisticated support in many ways.

Application areas of Group Decision and Negotiation include intra-organisational and inter-organisational coordination (as in operations management and integrated design, production, finance, marketing and distribution functions, such as coordination of all phases of the life cycle of a product), computer-supported collaborative work and meetings, electronic negotiations including negotiating agents and negotiation support systems, labour-management negotiations, inter-organisational, intercultural negotiations, environmental negotiations, and many others.

Papers can be submitted as full papers to be published either in Conference proceedings by Springer in the Book series of LNBIP (Lecture Notes in Business Information Processing) or as abstracts/extended abstracts/full papers to be published in Local Proceedings.

In the Local Proceedings the authors will keep the copyright. After the reviewing process, the authors could choose to replace their full paper in the Local Proceedings for abstract only. However, to be considered for the Conference Awards evaluation process, those papers should be available as full papers in the Local Proceedings, which will be on a stick that is given only to conference participants, at the beginning of the conference.

The topics are organized in conference streams that can be found on the conference website (<http://gdnconference.org/gdn2023/streams/>). Research in Group Decision and Negotiation has continued to expand, and many new research directions have been proposed. At GDN conferences, we encourage researchers to

present research in Group Decision and Negotiation even if (in fact, especially if) it does not fit into any of the above areas. We particularly invite Bachelor and Master students to submit their work to the dedicated Student Stream.

#### **Important dates:**

1. Deadline for Proposals of sessions, streams, panels etc: **October 15, 2022** (send your proposal to [gdn2023@gdnconference.org](mailto:gdn2023@gdnconference.org)).
2. Deadline for the submission to the Springer Proceedings: **December 15, 2022**.
3. Deadline for the submission to the Local Proceedings: **January 31, 2023**.
4. Deadline for the submission to the Doctoral Consortium: **March 16, 2023**.

## **1.4. New Special Student Application for GDN Conference**

During the GDN 2022 business meeting was proposed a Special Student Application for GDN Conference. This special application is for students who want to apply for free registration in GDN conferences.

It will be offered the opportunity to waive the registration fee for PhD/Master Students in the GDN field who are not authors/co-authors/presenters of papers in the conference. The main purpose is to increase the visibility of the community among students that would have the opportunity to get the first contact with the area. This is a strategy to increase participation of young researchers in our community.

The process consists of invite PhD/Master students to participate, waiving their registration fees. In that case, they could not be author, co-authors nor presenters of papers in GDN conference. The invitation for students can be done by Section officers, Stream Chairs and Program Chairs of the conference and Senior members of GDN community.

This opportunity is also announced in general in the GDN conference website and the applications must be evaluated by the Conference Chairs.

All invited students must fill out the “Special Student Application Form”, informing the research interest: title of PhD Theses/Master Dissertation and name of advisor; and motivation to attend the GDN Conference. Besides, the students should state who is supporting their subscription for waive conference registration fee. After the evaluation, the student will be informed if his/her application was approved or not.

### 3.1. Negoisst: slot open for new partners

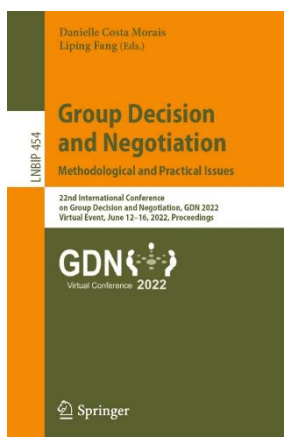

## 4. GDN JOURNAL: FROM THE DESK OF THE EDITORS-IN-CHIEF

In this newsletter, we would like to share two items with you: news on the journal's 2021 metrics and a call for special issue proposals.

When we assumed the editorship of GDN, one of our key goals was to lower the time to make an initial review decision on new submissions and bring the overall time to publication down. In 2021, the time from submission to first decision came down to 64 days (down from 76 in 2020 and 92 in 2019). The time from acceptance to online publication was 19 days. Also, we are happy to report that journal's impact factor increased from 2.648 to 2.928; the five-year impact factor increased to 2.527. The journal's CiteScore is 4.1. These are excellent numbers and we would like to thank all Board members and reviewers for their support. We also want to encourage everyone to submit to the GDN journal.

As many of you know, GDN has hosted various special issues. The SI in memory of Gregory Kersten has just been published online. We would like to see more SIs and thus welcome proposals for a special issue. Please send these directly to us. We are looking for topics that are currently gaining interest but have yet to become widely studied (in which case an SI can serve as a foundation point for our community) as well as for well-researched topics (in which case an SI shows the current state-of-the-art and current research advances).

We are happy to discuss potential paper submissions or ideas for a special issue and help you develop them, so just reach out. We love to hear from you!
