Group Decision and Negotiation Conference

Call for papers: GDN 2023

You are cordially invited to submit papers to the 23rd International Conference on Group Decision and Negotiation, GDN 2023, 11-15 June 2023, Tokyo, Japan. GDN 2023 will be held in the hybrid format of in-person presentations and virtual presentations by the choice of presenters.



The field of Group Decision and Negotiation focuses on decision processes with at least two participants and a common goal. Such processes are complex and self-organising and constitute multi-participant, multi-criteria, ill-structured, dynamic, creative, and often evolutionary problems. Major approaches include:

- 1. Information systems, in particular negotiation support systems (NSSs) and group decision support systems (GDSs)
- 2. Cognitive and behavioural sciences as applied to group decision and negotiation
- 3. Conflict analysis and resolution
- 4. Applied game theory, experiment and social choice
- 5. Artificial intelligence
- 6. Management science as it relates to group decision making and negotiation.
- 7. Many research initiatives combine two or more of these approaches.

Group Decision and Negotiation can be performed in an intra-organisational as well as an inter-organisational context. Both consist of complex processes, including preference elicitation, proposals and counter-proposals, preference adjustment, and choice. Communication and decision making are the two key process steps in Group Decision and Negotiation and thus require sophisticated support in many ways.

Application areas of Group Decision and Negotiation include intra-organisational and inter-organisational coordination (as in operations management and integrated design, production, finance, marketing and distribution functions, such as coordination of all phases of the life cycle of a product), computer-supported collaborative work and meetings, electronic negotiations including negotiating agents and negotiation support systems, labour-management negotiations, inter-

organisational, intercultural negotiations, environmental negotiations, and many others.

Papers can be submitted as full papers to be published either in Conference Proceedings by Springer in the Book Series of LNBIP (Lecture Notes in Business Information Processing) or as abstracts/extended abstracts/full papers to be published in Local Proceedings.

In the Local Proceedings the authors will keep the copyright. After the reviewing process, the authors could choose to replace their full paper in the Local Proceedings for abstract only. However, to be considered for the Conference Awards evaluation process, those papers should be available as full papers in the Local Proceedings, which will be on a stick that is given only to conference participants, at the beginning of the conference.

The topics are organized in conference streams that can be found on the website (http://gdnconference.org/gdn2023/streams/). Research in Group Decision and Negotiation has continued to expand, and many new research directions have been proposed. At GDN conferences, we encourage researchers to present research in Group Decision and Negotiation even if (in fact, especially if) it does not fit into any of the above areas. We particularly invite Bachelor and Master students to submit their work to the dedicated Student Stream.

- 2. Deadline for the submission to the Local Proceedings: January 31, 2023.
- 3. Deadline for the submission to the Doctoral Consortium: March 16, 2023.

In Memoriam



Love Ekenberg (1962 - 2022)

On September 19, 2022, Love Ekenberg, one of the world's leading researchers into decision theory and analysis, left us after a period of illness. He was active until the very end, among other things with an online course on decision theory and analysis in a digital transformation context. That course is aimed at doctoral students worldwide.

Love's focus was on how mathematics and logical systems thinking can contribute to better decisions and increased societal benefit in a variety of seemingly disparate societal areas such as nuclear energy, financial risk assessment, and community planning, all of which are group decisions - hence his deeply rooted interest in group decision making. Love's work embodies the spirit of freedom that characterises, and in many ways is a prerequisite for, the advancement of society.

His educational and scientific leadership was based on the conviction that open knowledge sharing and free thinking are the bases for the development of society. In addition, he was deeply committed to addressing society's major challenges in a democratic way, supported by logical, objective, and socially sustainable decisions, in Sweden as well as internationally.

Love Ekenberg was a researcher who was not afraid to take on difficult tasks. As a UNESCO-appointed professor to Africa, he was leading the effort to build a system of large-scale higher education in southern Africa that will multiply the population's access to decision-making knowledge and, in the long term, is also expected to boost the region's economic development. Last but not least, Love was always highly

appreciated and an extremely fun colleague to work with regardless of tasks. From his open-hearted character and his including sense of humour, he quickly made friends regardless of nationality, background, and age.

For GDN, us colleagues feel that Love has given us hints of the right scientific and moral direction to take, and he leaves a very large void. Thank you, Love, for all that you have given to us as a decision-making community.
